 SE WA ALTC will hire a Primary Care Liaison (PCL) who will work in Yakima/Benton/Franklin first two years and other counties second two years to do the following: Perform 4 clinic outreach visits per month enhancing health professionals and trainees' awareness of community agency role in ensuring age friendly care and build partnerships between the medical clinics and ALTC's ADRC/Family Caregiver and emphasize Dementia- early interventions and help facilitate referrals to ALTC service delivery systems.
