<p><b>If you have ANY of the following:</b></p> <ul style="list-style-type: none"> <li>Very short of breath, trouble walking and talking due to shortness of breath or skin color pale or gray OR</li> <li>Quick-relief medications have not helped, or Cannot do usual activities or Symptoms are same or get worse after 24 hours in the yellow flag area</li> <li>Peak flow: less than _____ (50% of my best peak flow)</li> <li>Skin color is pale or gray</li> <li>Fingernails or lips are blue</li> </ul>	<p><b>This indicates you need to be seen by a physician right away.
